1. General

We collect and use your personal data in order to provide you with personalized communication. We protect your data and respect your rights.

2. What personal data do we collect and use?

We collect the data that you communicate to us, data relating to your visits to our website, data relating to your connections and uses of our application.

Data provided by you

Some of the personal information we use has been provided to us by you. For example, when you downloaded our mobile application and created a profile. This includes your name, first name, address, gender, language preference, date of birth, interests and contact details. Via the website or the app

3. Why and on what basis do we collect your personal data?
